Dear Senator,

Union sportsmen do not need to read reports in the press to know climate change is already affecting the ways they pursue game and fish, the success of their days afield and the timing of their hunting and fishing trips.

Climate change has the power to fundamentally change the participation rates of our 3.2 million members that hunt and fish. As fish and wildlife habitat, abundance and distribution shift in response to a changing climate, patterns of recreational activities will shift as well. We can only imagine how a widespread national decline in hunting and fishing opportunities will affect the annual \$70 billion conservation revenue generated by hunters and anglers.

As partners of the Theodore Roosevelt Conservation Partnership, we believe that climate change legislation must address the impacts we already face. New dedicated resources are needed to protect and restore the natural environment, including fish, wildlife and their habitat, on which human health and economic vitality depends. Congressional action on climate change needs to include the following provisions.

**Dedicated Funding for Protecting Fish, Wildlife, and Ecosystems.** A share, no less than that contained in the House version of the bill (HR2454), of annual funding and not subject to annual appropriations should be used to protect and restore the natural environment, including fish, wildlife

and their habitat. A portion of these funds should be provided to ensuring that climate change strategies are integrated into state wildlife action plans, state coastal zone management plans, and other state wildlife species or habitat plans.

On behalf of union sportsmen, we urge your support of the natural resources, fish and wildlife adaptation provisions and ask that they be included in any climate change legislation ultimately passed by Congress.
