Dear House and Senate Agriculture Committees,

The undersigned hunting and angling, conservation, outdoor recreation, and scientific organizations extend our full support for the Voluntary Public Access Improvement Act of 2023, which would reauthorize the Voluntary Public Access and Habitat Incentive Program (VPA-HIP) at \$150 million. This highly successful state and tribal-led private lands access program is a top priority for America's sportsmen and women in the upcoming Farm Bill.

Throughout much of the country, access to quality hunting, angling, wildlife viewing, and other outdoor recreational opportunities is widely cited among the most challenging barriers to participation. As such, the ability to provide critical access opportunities, particularly in states with limited public lands, while safeguarding private property rights is of the utmost importance. Fortunately, VPA-HIP, as the only federal program designed to incentivize public recreational access on private lands, provides an opportunity to address this challenge. Since its reauthorization in the 2018 Farm Bill, the USDA has invested \$49 million through 27 state and tribal wildlife agencies to expand public access and enhance wildlife habitat. State and tribal wildlife agencies design access and habitat improvement programs to reflect local needs, land use, and landowner objectives, and enrollments are voluntary and incentive based. As a result, demand for the program continues to grow.

Local economies also benefit from the program. Because lack of access is a limiting factor for hunter and angler participation, areas with abundant hunting and fishing access attract visitors from across the country, which supports local businesses and drives economic activity. A recent economic analysis of the VPA-HIP estimated a nationwide return on investment of over 8:1. This directly supports thousands of jobs in the \$862 billion outdoor recreation economy and helps catalyze rural economies nationwide.

We thank you for supporting this important priority for sportsmen and women across the country, and we look forward to working with you to successfully incorporate this legislation into the next Farm Bill.
